

**Palm Pictures presents:
We Are Together: Many Voices for One Goal**

Enter the nationwide choir competition based off the film *We Are Together*, and be part of the national movement to bring all voices together in advancing the awareness of orphans and AIDS in Africa. Demonstrate advocacy on behalf of the Christian community, and encourage others to support the Agape Children's Choir.

Who is Eligible? Any officially recognized choir group that wishes to participate. This includes church choirs, worship teams, and high school and university choral groups. Remixes of the material is encouraged in order to judge creativity. The contest is not open to professional singers or performers, and each contestant under the age of 18 must have a signed consent form by choir instructor or parent.

How do I Enter My Group? First, film your ensemble singing "We Are Together" (choral arrangement can be changed for each specific choir). Then, upload your performance to YouTube and email the link to Palm Pictures at: press@palmpictures.com. You must also fill out and email or fax (212) 320 - 3729 the liability form attached below to *Deborah Schonfeld* in order to be officially entered in the contest. Entries will be received beginning on September 15th, and the contest closes on December 15th. THE FIRST FIVE GROUPS JUST TO PARTICIPATE WILL BE FEATURED ON THE HBO HOME PAGE.

The Judges will include a selected panel of celebrities. They will view each performance and base their decisions on showmanship, musicality, creativity, technical achievement, and overall performance. Keep in mind that excellent sound quality of your submitted video will help a great deal in the judging process.

The Music includes the song "We Are Together" from Paul Taylor's documentary of the same title. You can download the song at: www.wearetogether.org Click on the choir competition button to get all information.

For ideas on how to perform the "We Are Together" tune, purchase the documentary and watch the Agape Children's Choir in action. To get even more involved in the cause, consider holding a screening at your church or organization, invite friends and family, and raise money for your group or community. For specific details, see the *We Are Together* website.

The PRIZES consist of a Palm Pictures pack for the top five contestants. The prize packs include a music library and the total value is worth over\$1,000.00. The winning group will receive a new set of choir robes for their entire team. Winner will be determined on or around January 15, 2009.

TO ENTER: NO PURCHASE NECESSARY; void where prohibited. The "2008 Choir" Contest (the "Contest") will be held virtually through online media. Interested participants must register by emailing the following form to deborah.schonfeld@palmpictures.com starting August 1, 2008. Palm Pictures will not limit the amount of entries. The eligible entries will receive an email from Palm Pictures stating confirmed registration, if entrant does not receive email, entrant is not registered to upload and participate. Once confirmation has taken place, each contestant will videotape a performance with a choir of a rendition of "We Are Together" (put in writers) not to exceed five minutes. When finished you will upload your video(s) to youtube naming the video - WEARETOGETHER (CHOIR NAME) The video audition will be followed by a critique and evaluation by the judging panel that will be announced. Any member of the judging panel has the right to end the audition at any point in the song. At or about midnight on December 20, 2008 the judges will determine and announce the top five finalists.

2. Eligibility Restrictions:

2.1 The Contest is open to entrants who are legal residents of the United States of America, who are physically located and residing therein, and who are not subject to any agreement which would interfere with their ability to enter this contest or assign all rights hereunder., ___17___ years of age on July 28, 2007 (you must be born on or after 1990) . If you were born before or after this window, you are not eligible to participate. You must have a valid proof of identification to enter (examples include a valid drivers license or passport). If you are less than 18 years of age you must be have **full written permission of your legal guardian or Choir Conductor**

2.2 The Contest is not open to professional singers or performers and each contestant on penalty of disqualification will sign a certification that he or she is qualified to participate. If you enter your choral group, you are agreeing that you or your choral members you do not have any of the following:

- a contract for talent representation (for example, a talent agent or manager)
- a music recording artist
- an acting and/or modeling contract
- a merchandising agreement; or,
- any other contractual arrangement that would prohibit you from entering into a management contract, recording contract, talent contract, acting contract and/or merchandising contract.

2.3 Employees, shareholders, officers, directors, agents, representatives, and their immediate family members and those living in the same household of Palm Pictures, corporate sponsors or any person or entity connected with the production, administration or judging of the auditions, or any of their respective parent companies, affiliates, subsidiaries, agents or representatives of any of the foregoing entities are not eligible. The term immediate family members includes parents, children, spouses, in-laws, and people in spouse-like relationships, including those in step and half relations where living in the same household.

2.5 All contestants must sign a release and waiver form prior to the event by which they agree to hold Palm Pictures LLC, and other affiliates, officers, directors, partners shareholders and agents not liable for

any claims resulting from participation in the Contest. The grand prize winner must sign a receipt of prize and waiver and release of liability and will be responsible for any taxes.

3. **PRIZES:** Each of the five finalists will receive a prize pack PalmPictures. The approximate value of each individual prize pack is \$1,000. The approximate value of the grand prize is: under \$5,000.

4. **SELECTION OF WINNERS:**

4.1. There will be a panel of judges appointed by Palm Pictures LLC. Having good quality sound in the video of the performance will help greatly in the judging contest. Judges have the right, in their sole discretion, to select fewer than five (5) Finalist(s) based on insufficient number of eligible semi-finalists.

4.2 Decisions of Palm Pictures LLC management and judges with respect to the Contest are final.

5. **Conditions**

5.1 Payment of all federal, state and local taxes is the sole responsibility of the winner. Palm Pictures LLC will submit an IRS form 1099 or the equivalent for any individual who wins \$ **(check with Marty)** or more in prizes in any calendar year.

5.2 By participating in the Contest, each contestant agrees to allow their name, voice and/or likeness used in any advertising or broadcast material relating to the Contest for a period of one year without additional financial compensation or other consideration and to sign a publicity release prior to the acceptance of the prize. The top five finalists are required to sign a receipt verifying eligibility prior to acceptance of any prize of more than nominal value. Before claiming a prize are also required to sign a Liability Release and/or Travel Release if the prize to be awarded is valued at \$600 or greater, if the Contest or the prize entails dangerous or potentially dangerous activity, or if the prize includes the provision of transportation, whether or not such transportation is provided by Palm Pictures LLC. 5.6 PLEASE REFRAIN FROM WEARING ANY CLOTHING ITEMS BEARING DESIGNER OR SPORTS LOGOS OR BEARING THE NAME OR LIKENESS OF A CELEBRITY, LIVING OR DEAD TO ANY OF THE VIDEOTAPING.
